We now advise that the Capital Raising Committee of the Board of our Bank has approved today raising of funds through issuance of Basel III Compliant AT-I (Additional Tier-I Capital) Bonds, i.e. Perpetual Debt Instrument, as per the regulatory definitions of the Reserve Banks of India of Rs 500 crore with Green Shoe option of Rs 500 crore (total size not to exceed Rs 1000 crore) on Private Placement Basis depending upon the market conditions.

The meeting concluded at 6.15 p.m. today.
